**RELEASE OF LIABILITY, HOLD HARMLESS AGREEMENT,
COVENANT NOT TO SUE, AND INDEMNIFICATION AGREEMENT**

Independently of, and in addition to, the Training Registration form that I am submitting to Dodge County Canine (hereinafter referred to as DCC), I understand that DCC, as further consideration for my dog's admission to the training program, requests that I agree to (1) release DCC of liability for certain claims, (2) hold DCC harmless on certain claims, (3) covenant not to sue DCC on certain claims, and (4) indemnify DCC against certain claims, as described in this agreement.

In considering these requests, I understand and acknowledge that my dog's participation, and my participation, in the training session is primarily for the benefit of me and my dog, and I understand and acknowledge that there are risks inherent in the participation in any training session, including risks that other dogs may become aggressive, that my dog may become aggressive, and that I may be bitten, scratched or otherwise physically injured by contact with one of the dogs participating in the training, including but not limited to my own dog.

In consideration of all of the foregoing, I hereby agree to the following (strike any paragraphs to which you do not agree):

- 1) I hereby release DCC and its successors, assigns, heirs, directors, officers, employees, representatives and agents (collectively, "DCC") from liability for and on any and all claims and demands that I could, now and/or at any time in the future, make, assert, lodge, and/or bring against DCC for damages, whether alleged to be based in negligence, grounded in statute(s) or based on any other legal theory, that arise out of actions by my dog during, before or after the training session and/or that arise out of the actions of another dog or another person during, before or after the training session, including but not limited to any and all claims alleging physical and/or or emotional injury or injuries to me or to anyone else and any and all claims alleging damage to my tangible property or to anyone else's tangible property; and
- 2) I hereby agree to hold DCC harmless from any and all liability on any claims, or portions thereof, released in the release above; and
- 3) I hereby covenant not to sue DCC on any claims, or portions thereof, described in the release above; and
- 4) I hereby agree to defend and indemnify DCC for (to pay on DCC's behalf) that portion of any damages it may sustain and/or be found to owe to any third parties and to be responsible for any and all attorneys' fees, litigation expenses and court costs that it may incur as a result of or related to any claims made against it by other people or business organizations that arise out of my actions or the actions of my dog, whether in whole or in part, and whether the claims are grounded in statute(s), negligence, intentional tort, and/or other bases of liability.

THIS AGREEMENT WAIVES IMPORTANT LEGAL RIGHTS THAT YOU MAY HAVE. READ CAREFULLY BEFORE SIGNING.
